



Call for applications:

Bring more daylight into your sports clubhouse

In 2016, the VELUX Group will celebrate its 75th anniversary. One of the initiatives to mark this milestone is the donation of a complete installation of VELUX roof windows to sports clubhouses all over Europe.

The VELUX Group has delivered products for better living environments and healthier homes with daylight and fresh air for 75 years. As daylight providers, we know how much a healthy indoor climate means to the performance and health of people. Therefore, as part of our 75th anniversary celebration in 2016, we have decided to donate a number of VELUX solutions to bring fresh air and better daylight to sports clubhouses throughout Europe. In return, we ask for images and documentation of the sports clubhouses "before and after" and images of the people enjoying the daylight and fresh air through those new windows.

Scope

Sports clubs can apply for a donation of up to six VELUX roof windows making a simple registration on the website and upload a photo of the existing clubhouse.

The donation covers one complete installation of six (6) VELUX roof windows per country. By complete installation we mean VELUX roof windows (GGL, GGU, GPL or GPU or similar flat roof windows), installation, installation products, blinds and shutters. The installation must be carried out by an authorised professional installer.

The donation of VELUX solutions is aimed at non-professional/non-profit clubs or associations with sport activities incl. scouts.

Selection of winners

After the submission deadline 15 October 2016, the local VELUX sales company will select 3 candidates among the participating clubs from that particular country. The contact persons for the three selected clubs will be contacted by the local VELUX sales company and asked to send in sketches/drawings and an installer offer for the installation at the latest by 15 November 2016.

After the November 15th, a jury consisting of an architect from VELUX A/S, the VELUX Group's global product director, a VELUX daylight expert and representatives from the local VELUX Sales Company will select a country winner among the three candidates from each of the participating countries for the donations. The number of windows donated (max 6) will be based on the recommendations of the jury for each specific project.

How to participate?

All sports clubs must fill in an application form, which is available on www.velux.com/sportsclubs
Deadline for application is 15 October 2016.

The application must include:

For first round:

- Name of the sports club
- One image of the clubhouse
- Name, email address and telephone number

If selected to be among the 3 candidates form each country:

- A description of why the clubhouse should win (max. 200 words)
- Drawings/sketches of the clubhouse, showing how the VELUX solution will be installed and where
- An offer for the installation from the authorised installer

Timeline

January – October 15	Sports clubs and associations can apply for a VELUX product package of six VELUX roof window solutions.
October 15	Application deadline and jury meetings at local VELUX sales companies
November 15	Application deadline for extra info from the selected candidates (final jury meeting by end November)
December	Winner announcement
January 2017 ->	Refurbishment and installation in winning sports club buildings start. Each winner sends documentation and before & after pictures and/or films to velux75@velux.com
